Notice under Section 138 of the Negotiable Instruments Act,

Dear Sir,

I have been engaged and instructed by M/s. Unthinkable Solutions LLP, having Registered Office at 6th Floor, Metropolis Mall, Opposite Vidyut Sadan, Delhi Road, Hisar - 125005 (hereinafter referred to as "**my client**") to serve you with following notice:

1. That in partial discharge of your existing, outstanding, and legally enforceable liability, you issued an account payee cheque under your signature in favour of my client with an assurance and promise that the said cheque would be paid upon presenting the same at the bank for its payment.
